Reservations & Cancellation Policy

- Court reservations may be made by members only, no earlier than 7 days in advance.
- Cancellation of a court or private lesson more than 24 hours in advance the customer will not be charged.
- Cancellation of a court or private lesson less than 24 hours notice will result in a charge.

Junior Program Credit & Refund Policy

- There will be no credits/refunds issued to juniors who withdraw from the Junior Program
- Credit reimbursements will not be issued for lessons or programs missed.
- Junior Program make-ups will not be allowed for lessons missed.
- In case of an injury which restricts a member from participating, a credit will be given less 10% administration fee.
